With reference to your application dated -19/06/2023 and subsequent school inspection in this regard, I hereby convey the grant of Recognition to **National English Medium School and Jr.college Mirjoli Tal – Chiplun Dist –Ratnagiri** (Name & Address of school) for class I to VIII standard for the period 2022-2023 (no. of years) from the academic year 2022-23 to 2024-25 in compliance to section 18 of Right of Children to Free and Compulsory Education, Act, 2009 and rule 2011.

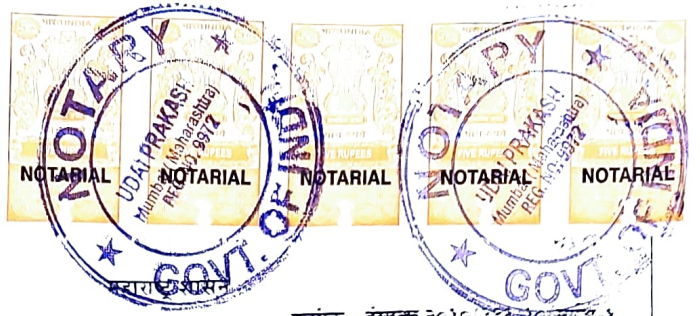
The above recognition is subject to the following conditions:-

1. The temporary recognition accorded to the school is valid from the academic year 2022-23 to 2024-25 and is to be renewed at an interval of every **Three** years.
2. The grant of recognition is available initially for classes I to VIII standard and to be extended for Secondary /Senior Secondary classes subsequently in due course of time.
3. The school shall abide by the provisions of the Right of Children to Free and Compulsory Education Act, 2009 and the Rule 2011 (State Education Act/Rules).
4. The school shall admit in pre-school / class I to the extent of 25% (%age) of the strength in each class, children belonging to Weaker Section and Disadvantaged Group in the neighborhood and provide free and compulsory elementary education till its completion.
5. The school shall maintain a separate bank account for the purpose of reimbursement.
6. The school shall not collect any capitation fee and subject the child or his or her parent or guardian to any screening procedure.
7. The school shall not deny admission to any child, -
 - a. For lack of age proof if such admission is sought subsequent to the extended period prescribed for admission.
 - b. On the ground of religion, caste or race, place of birth or any of them.
8. The school shall ensure that,-
 - a. No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
 - b. No child shall be subjected to physical punishment or mental harassment.
 - c. No child is required to pass any board examination till the completion of elementary education.
 - d. Inclusion of students with disabilities/ special need as per provision of the state rule 23 (rule/ clause of State Act).

- e. The teachers are recruited with minimum qualifications as laid under rule 23(1) (rule/ clause of the state Act).
- f. The teachers perform his duties specified under 24(1) (rule/ clause of the state Act).
9. The school shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
10. The school shall maintain the standards and norms as specified in rule 19. (rule/ clause of the state Act).
11. No unrecognized classes shall run within the premises of the school or outside in the name of school.
12. The school building plan must have been approved by the current rules or G. Os. The school building or other structures and the grounds are used only for the purposes of education and skill development. Construction work within the compound should not be carried out in school working hours and safety measures in all respect are under whole responsibility of the managements.
13. The school is run by a society registered under the Bombay public trust Act 1950 (Act under with Society is registered), or a public trust constituted under any law for the time being in force.
14. The school is not run for profit to any individual, group or association of individuals or any other persons.
15. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared.
16. The school shall furnish such reports and information as may be required by the competent authority from time to time and shall comply with such instructions of the State Government or the competent authority as may be issued to secure the continued fulfillment of the condition of recognition or the removal of deficiencies in working of the school.
17. Marathi (language subject) shall be taught as a subject from in standards I to X in all schools notified under Act 2020 (Mah.Act.No.III of 2020) (concerned Act/ rule) from academic session recognition is granted.
18. The school shall abided by the provisions of the RTE Act 2009 (State Act/ Rules).
19. The certificates of recognition issued by the department shall be subject to the fulfillment of deficiencies if any pointed out by the department at any stage/ time.
20. The management shall rectify the deficiencies pointed out in infrastructure or administration by the authorities.
21. The management shall apply for renewal of recognition three months before the expiry of this order to this Education Officer (Primary) Zilla Parishad Ratnagiri (Name & Address of the certificate issuing authority).
22. The management shall follow the directions issued by the Government/ Department form time to time keeping in view of the safety and security of the children and the overall administration of the school.
23. The recognition shall be withdrawn if any contravention of the provisions of the Act, Rule or the conditions of recognition are found and proved.
24. The school management shall have to full responsibility if any court cases arises this regard. The management is not entitled to seek affiliation to other Board without obtaining NOC from the State Authority (Concerned State Authority).

सोबत जोडलेल्या संस्थेच्या प्रस्तावाच्या अनुषंगाने आपणास कळविण्यात येते की, मिस्त्रांली मुस्लिम अंजुमन, मुंबई या संस्थेद्वारे संचालित इंग्रजी माध्यमाच्या इ. ७ वीपर्यंत सुरु असलेल्या नॅशनल इंग्लिश मिडीयम स्कूल, मिस्त्रांली चिपळूण, जि.स्नागिरी येथील प्राथमिक शाळेत जोडून इंग्रजी माध्यमाचे इ. ८ वी ते इ. १० वीचे वर्ग कायम विना अनुदान तत्वावर सुरु करण्यास शासन स्तरावरून पुढील अटी व शर्तीच्या अधीन राहून परवानगी देण्यात येत आहे :-

Subject :- Regarding permission to start English medium classes from Class 8th to Class 10 on permanent non-subsidy basis in addition to primary school up to Class 7 of English medium.

Pursuant to the proposal of the attached organization, you are hereby informed that English medium etc. operated by Mirjoli Muslim Anjuman, Mumbai. National English Medium School, Mirjoli Chiplun, Dist.Ratnagiri, which continues up to 7th Std, is connected with the primary school of English medium etc. 8th Std. Permission to start 10th class on permanent non-subsidy basis is being given by the government subject to the following terms and conditions.

1. Within one year from the date of permission order, the organization will be required to apply to the State Board for affiliation certificates (first provisional and then regular).
2. The said permission order shall be subject to fulfillment of all the criteria required for the Affiliation Certificate (Regular Affiliation) issued by the State Board.
3. For Affiliation Certificate by State Board (Regular Affiliation) If the prescribed criteria are not fulfilled, the said permission order will be considered cancelled.
4. Shifting of the said school from the permitted location will not be permitted.
5. It will be mandatory for the concerned school to follow all orders issued by the Government, Director of Education (Secondary and Higher Secondary), Pune and State Board.
6. It will be necessary to teach the curriculum prescribed by the Maharashtra State Board of Secondary and Higher Secondary Education in classes from Class 8 to 10 where permission has been granted.
7. By this order permission is being given to the search classes which were going on in the school at the time of the permission order.
